How our program works

We are your steadfast friend throughout this entire process. Acting as a helpful intermediary, we provide assistance and guidance to both intended parents and Surrogates, connecting you all to the necessary service providers for your journeys.

Our primary role is to match you with a caring Surrogate and connect you with the four other key service providers you need to complete your journey. We remain by your side throughout your entire journey. We provide regular updates, guidance, and support, and assist in addressing any challenges that may arise.

We are here to ensure that you, and your Surrogate, are armed with the information and resources you need to complete your journey with love and ease.

In this guide, you'll find both 'fixed' (f) and 'estimated' (e) costs, as you'll establish separate cost agreements with each service provider. NewGen Families fee will be fixed; however we can only provide estimates for all other services.

We maintain close collaboration with our partners to ensure accurate cost information, aiming to provide you with a transparent budget for the various expenses you may encounter throughout your journey.

USA Surrogacy Costs

While our agency fee is a fixed cost, we also offer estimates for both known and unknown Surrogate costs that may arise throughout your journey. Estimated known Surrogate costs are those you will incur, while estimated unknown Surrogate costs depend on your individual needs, choices, and the unique progression of your surrogacy journey.

If you are collaborating with NewGen in the creation of your embryos, please note that the payment terms may differ from those provided in the above details.*

B. Estimated unknown Surrogate costs

We ask that you have access to an additional \$20K for the following potential unexpected and unknown Surrogate related costs. Escrow must always maintain a minimum balance of \$10,000USD

Additional service provider costs

NewGen Families will match you with a Surrogate and coordinate your entire journey, however, you will also require additional service providers to complete your journey. Some of you may arrive at NewGen with either a clinic or an attorney that you've already started working with, and that's great! For many, though, it is also our role to connect you to our network of trusted partners. We will help understand which partner will be right for you based on your budget and needs.

You will also require the following services to complete your journey:

1. IVF clinic for all medical services (egg donation, embryo creation, PGT-A testing, embryo transfers etc.)
2. Legal services for contract review, Gestational Carrier Agreements, Pre-Birth Orders etc.
3. Escrow account to manage your funds
4. Newborn Insurance (for non US residents)

Each service provider will have its own cost structure, separate from NewGen's agency fee.

See below for guidance on budgeting for the costs associated with your entire journey.
